The elite people's lives not much affected, but the poor were struggling a lot. It took them a decade to recuperate from the effects of the conflict. On the other hand, the class division gallops unrestrained. The elite people dominate working class, they worked more for less penny. The people suffered by class struggle.

The elite people treat lower class people as a slave, the upper crust assumed that the poor existed to serve them. Those in power blocked the social mobility of the under privileged. Estha and Rahel, they called Velutha as uncle. They were kind to him, they felt safe. He had a very strong physique. So, Ammu like Velutha. Uncle became father but that doesn't happen because they are elite people their ancestors believes that the poor people were untouchables. However, they don't even allow them inside the elite's house also don't give them water in the glasses elite used. Mammachi only allowed Velutha in their factory outside because of some handyman work. Baby Kochamma also a cunning lady like an antagonist figure she doesn't like twins and their mother, she loves father Mullingan but he denied her, once he was father then had a faith in Vishnu became a saint. Baby Kochamma had a touch with him to his death. She knew the truth about Velutha and Ammu's relationship. That's why she falsely blamed Velutha. That allegations where he raped Ammu and also kidnaped twins. But he not, the police sight him in his house with twins their false judging was Velutha kidnaps them but the twins hide there because Sophie mol was drowned in river. When Sophie mil arrived Ayenemem, it's silence gone. The cops beat him to death. Velutha's death remained unresolved. Neither Estha nor Rahel's mistakes were exposed or acknowledged. Sophie mol's death also went unexplained. As a result of their mistake, Ammu sent Estha to his father. Although Rahel was reluctant to part with Estha, they were separated.

Years after Estha's departure, Ammu met a tragic end, she was raped and murdered at the age thirty-one. Her death too remained injustice. In fact, none of the character who died in this story had their deaths explained or justice served.

In cases of social injustice, gender inequality plays a major role, creating significant disparities between men and women. Women were often restricted from venturing out, denied the right to speak, vote, and were even subjected to the practice of sati in the postcolonial period. Women were primarily confined to childbirth, cooking, and household chores. Males dominated women in a patriarchal society. In the novel, Chacko was allowed to pursue higher studies abroad, while Ammu faced numerous obstacles within her own home. Treated disrespectfully, she sought solace in love and eloped with another man. However, her married life was also fraught with dominance, leading her to divorce and return to her mother's house

with her children. Even there, she faced humiliation, highlighting the pervasive dominance of women in patriarchal society.

The novel highlights the deep-rooted caste discrimination that divides society into hierarchical groups. The character Velutha, an untouchable handyman, faces severe caste discrimination in the novel. His tragic murder is a stark reminder of the physical and psychological violence that can result from castebased discrimination. Ammu loves Velutha, but they were separated because of this caste division. The setting of Ayenemem House reflects the caste hierarchy. The elite class, the twins Estha and Rahel's family, lives a privileged life. However, the children don't seem to care about the caste system and love Velutha. They don't follow the elders' words about caste disparities. The lower-caste, like the untouchables, live in small huts near the riverbank. This shows the marginalized community. The river, a symbol of flow, liberation, and transformation, contrasts with the stagnant reality of the poor, who are isolated and forced to practice Dalit customs. This highlights the barriers they face.

Roy's depiction of postcolonial India and the postcolonial theory has been examined. Postcolonial theory provides an understanding of the impact of colonialism and marginalized community in India. Author chose this theory to convey the colonial power dynamics in India. The caste system gender inequality is a major consequence in social hierarchy. These are the ongoing concepts in Indian society. Roy masterfully portrayed social injustice in the God of small things. For example, in Velutha a paravan forced to practices dalit customs. The nobles were paid less taxes but the working class paid three by fourth of their wages for tax in postcolonial period. The caste system a legacy of colonial rule, remains a significant source of social injustice.
