

# A comparative study of attitude and achievement of the students studying English in different types of schools

Achievement test paper consists of 20 questions of tense, preposition, articles; phoneme, identification, unseen passage and composition **.Simple statistics has been used in the study.** 

#### 5. Findings and conclusion

The null hypothesis was rejected. Significant difference was found between the attitude of the boys and girls of different types of schools towards English. The attitude of the girls of different type of schools towards English is more positive than the boys of different types of schools.

Null hypothesis was rejected. Significant difference was found between the achievement of the boys and girls of different types of schools in English. The achievement of the girls of different type of schools in English was found to be higher than the boys of different types of schools. It can be concluded from the findings that the attitude of all the students towards English is positive. And the attitude of the girls towards English is more positive than the boys. But the achievement of the students in English is quite low. The girls are performing a little better but the overall performance of the students in English is not up to the required standard. This poor performance seems to be the result of certain drawbacks at different levels of planning and implementation. First of all it seems that the textbooks of English designed to develop the four language skills: listening, speaking, reading and writing are not meeting the set goals. Secondly there is a scarcity of competent teachers in English, and thirdly the lack of conducive environment in family and society for learning of English.

# 5. Educational implications

- 1. The investigator has made an attitude test and an achievement test of English for class 10<sup>th</sup> in his research. These tests may prove useful for the students of other classes, teachers of English and the researchers doing their study in this field. Such tests seemed deficient in this field.
- 2. The achievement test prepared by the researcher will be helpful in the construction of diagnostic tests and remedial measures in English.
- 3. Keeping in mind the conclusions of this research, the teachers of English will try to make their teaching more interesting and effective to enhance the performance of their pupils.
- 4. This research will be helpful in providing guidelines and motivation to the new researchers in field of English.
